## POSSIBLE TOPICS FOR DISCUSSION

- ➤ Consider what you have heard about the challenges of policing, the historical and social history of policing and the fight for police legitimacy and cooperation. How can we take all these perspectives into consideration to integrate the role of policing better into the community?
- ➤ How would you build a better, fairer police force? What role, if any, does the community have in improving this relationship?
- Although the terms 'law enforcement' and 'policing' are often used interchangeably (including in this workbook), some have argued that law enforcement is only one component of policing. In this view, policing encompasses other roles in addition to merely enforcing the law, such as community service and administering care to those undergoing medical crises. What do you think are the proper and reasonable roles society should expect police officers to perform?
- ➤ Imagine that you were given the time and resources to design a system of law enforcement from the ground up. How would you build a better, fairer police force? How would it be similar to American law enforcement today? How would it be different?
