July-August: VICTIMS SURVIVORS AND OFFENDERS - WHERE IS JUSTICE?

This course will look at the cycle of trauma from victim to offender and how to break the cycle. Dr. Golden is the director of the New Hope Clinic, a licensed sex therapist, and an expert on addiction and domestic violence who will lead this course, in addition to our own Hinda experts.
